New Updates Online

Dear Watchers,

You all know that the CDM is in the dumps. You may have noticed that this is also reflected by the CDM project pipeline that sees less and less projects up for validation. And with the current climate targets in place we don't need any more! However, given that there are still new projects coming up for validation and registration and that registered projects (currently more than 6.500!) are slowly starting to request a renewal of their initial crediting periods (if they had chosen a 7 year crediting period), we think that it is important to continue our updates in a revised way (see here). This was also confirmed by our survey where many of you participated. Many thanks for all your feedback!

The revised updates will also take into account an expected appetite for programme of activities (PoAs). PoAs are getting more and more popular because it is possible to add components of the programme even after its registration. In short, PoAs are activities that coordinate or implement policies or measures to reduce emissions via an unlimited number of small components. For example a cook stove project with many cooking units can also be added even if the "main" PoA is already registered. We'll send a more detailed update about what PoAs are about in a separate email.

From today we will send you a weekly summary with the following information and publish this information online:

- CDM Projects under validation and requesting registration
- PoAs under validation and requesting registration
- CDM Projects requesting renewal of crediting period

We'll also like to add a novelty to the geographical scope: From now, we'll exclude CDM projects and CDM PoAs located in China for distribution on the global network list.
