RE: CSO active observer selection

Dear Mr. Fakir and Mr. McDonald,

As civil society groups concerned about the Green Climate Fund, we want to ensure that the GCF is a transparent, democratic, inclusive, and effective institution and, equally, that our participation in this process upholds these same principles. Given the diversity of civil society groups and constituencies, selecting permanent active civil society observers in a fair and inclusive manner is necessarily a sensitive and time-consuming exercise that poses a number of potential challenges.

We are not in a position to complete this process in a way that would be broadly perceived as fair and inclusive in time for the June 25-28 board meeting in South Korea. This is because (1) the decisions from Berlin setting out the terms, requirements and expectations for active observers were only recently posted on the GCF website, and not disseminated; (2) accreditation has not been completed, so we don't know with certainty who is eligible to participate; (3) we do not know if support for Southern participants to attend will be forthcoming, so we do not have clarity on the financial limitations that might exist for potential active observers; and (4) resources have not been made available to allow for a fair, inclusive selection process with broad outreach. For reasons of transparency, accountability and legitimacy, we will instead select "active" observers for the June Board meeting from among those able to attend, and complete the more inclusive self selection process for permanent representatives thereafter.

Board decisions in June could help facilitate a proper self-selection process. Resources and support are needed to design and carry out a legitimate selection process that reflects the depth and breadth of global civil society—from affected communities to national and international organizations. We note that the credibility and legitimacy of the selection process for observers for the Climate Investment Funds was increased considerably by the fact that it was facilitated with due diligence by an independent entity that did extensive outreach and included an advisory council that interviewed prospective candidates. We believe that a similar process would be appropriate for the GCF. We further note that the participation of CSO observers from developing countries in Climate Investment Fund meetings is fully financed. Such dedicated support is also necessary for the GCF.

We request that these issues be discussed at the next Board meeting, and we look forward to working with you in South Korea in June to further develop how and when a CSO active observer selection process can best be taken forward.
