What is a PoA (Programme of Activity)? Usually, policies or standards cannot be considered as CDM project activities. However, in the form of a so-called Programme of Activities, also policies that incentivize GHG reduction or removal by sinks, can also qualify for the CDM. The idea was to broaden the CDM field and spread GHG emissions reduction activities that would have been difficult and time-consuming to develop on a project-by-project basis.
